

# Nettardue

## De-waxing detergent with high degreasing power

Concentrated de-waxing and degreasing detergent to remove old layers of metallized and in emulsion waxes, from vinyl floors, PVC, rubber and linoleum. Very effective as an intensive cleaner for decking, to remove previous oil-based treatments.

### Instructions for use

#### As a de-waxing detergent

Add 4 – 8 caps of Nettar Due to 10 litres of water (2 – 4%), spread the product on the floor and let it act for 5 – 10 minutes. Clean the floor with a buffing machine equipped with a green pad. Rinse well with clean water.

#### As an intensive decking detergent

Spread the pure product on the floor and let it act for 5 – 10 minutes. Clean the floor with a buffing machine equipped with the appropriate decking pad. Rinse well with clean water, if possible use a pressure washer.

#### As a detergent

Nettar Due can also be used as a detergent, adding 1 – 2 caps of product every 10 liters of water (0.5 – 1%). Rinse with clean water.

**Warning! Nettar Due is a corrosive product! Always protect yourself by wearing gloves and protective goggles during use. Also protect any delicate surface near the areas to be treated.**

### Notes

Shake before using

Do not use on untreated wood

The formulation of Nettar Due is specific in particular for the removal of the Resinal Wax metallized wax.
